Learning and assessment resources

Online learning and assessments are done through Aka Toi, the Careerforce online learning platform. This is where the assessments are located. There are also links to suggested learning resources to support the learner's journey.

The assessment of this programme includes the learner responding to assessment tasks, gathering suitable workplace evidence or examples of work, and Kōrero Matanga (where there are minor gaps in the written work and/or the workplace evidence presented).

Kōrero Matanga is a structured professional conversation between the learner and assessor. It enables the learner to demonstrate their knowledge and skills through story-telling and sharing experiences. Kōrero Matanga can be either face-to-face, by phone or Skype.
