

# Measures of success; Cultural Monitoring and Taiao management Training Course

# Principles of Cultural Taiao Management.

Te Arahanga has developed its own set of principals when working with the Taiao (the natural world) and believes by retaining our core values we will be successful.

Ka tu Te Whare o Rangi rāua ko Papa

- That sustainability of all Rangi and Papa's tamariki are considered in all our decisions.
- Ensure our Kaitiakitanga obligation to our mokopuna and their mokopuna are met.
- Ensure that our pūrākau and tawhito korero are understood and respected in all aspects of environmental management.
- We uphold the manaaki tikanga of our Tūpuna by ensuring that our Treaty partners have an insight into our tikanga and kawa.

# Goal: To have tauira from whanau, hapū and Iwi members who have a comprehensive over - view of taiao management and are recognised by their whanau, hapū and Iwi as the tohunga for these areas.

# **Objectives:**

- That all tauira are familiar with the whakapapa connection of their whanau, hapū and iwi with their whenua, awa and moana.
- That tauira are aware of their tikanga and kawa for their whenua, awa and moana.
- That tauira are fully aware of both Lore and Law that pertain to modern taiao management.
- That tauira are fully aware of their whanau, hapū and iwi lore, the law, tikanga and kawa for acting as kaitiaki for any taonga and kōiwi that may be exposed.

# **Development Strategy:**

- To develop online modules in each area of Taiao management by December 2019
- To partner with NZQA institutions in 4 fields (water quality testing, electric fishing, translocation of stock and stock assessments)
- To work with partners and develop modules for working with the Archaeologist.
- To work with partners and develop the GPS (Global Satellite Positioning) mapping module.

# **Measures of Success:**

Te Arahanga will guide them along the path and ensure that their work is clear, coherent and includes all aspects that are required by whanau, hapū and iwi to make their project a success. Te Arahanga believes strongly that this course should empower haukāinga.

Success would be tauira providing a taiao based plan for their whānau, hapū and lwi to complete a taiao project; with the appropriate whakapapa, pūrākau and connection to the haukāinga and their taiao.

As mentioned in our application Te Arahanga is open to partnering with other organisations however the value base would have to be similar.

#### **Measurements of success**

- Success will be measured on the tauira being able to identify each aspect of the information they have received and apply to their nominated project.
- Success will also be measure on quarterly presentations to their whānau, hapū and iwi on their nominated project.
- Final Assessment will be presentation of their nominated project to their whānau, hapū and Iwi.
