# Chairperson's Report Nā, Glenice Paine

Time has certainly flown by since our last pānui. The feedback we have had regarding the Te Ātiawa Day and AGM weekend prior to Christmas has been very satisfying. I think all who participated in that event considered it to be an outstanding success and a fitting end to our Treaty Settlement year. Conducting similar events in future is certainly on the Boards' long term agenda and will be considered in due course. Such large scale events are unlikely to be conducted annually however, due to the significant costs involved.

At the last AGM, the Trust completed the transitional rotation of Trustees of the new Te Ātiawa o Te Waka-a-Māui Trust. In accordance with the Deed

# Chairperson's Report (cont.)

the next Trustee elections will occur from 2016 onwards. The rules around the rotation of Trustees under the new Trust Deed have exposed a number of what I consider to be minor flaws in our Constitution. The result of these flaws is that in some years we will need to conduct two sets of elections, and in other years no elections will occur. This is an unintended consequence of the transition to the post settlement era and has prompted the Board to place a review of the Deed on the near term work plan. Since settlement the reality of being a Trust in the post settlement era is quickly becoming apparent. In order to meet our obligations as kaitiaki over the settlement assets, more resources will need to be directed to that purpose. The cost of doing business continues to increase, and the decisions to be made around the management of our assets are more acute. The Boards' understanding of these challenges is improving as time progresses, and by the time we report to you again at the AGM the picture for us all moving forward should be clearer. What is clear though is the need for capable and committed Trustees and professional advisers.

One of the high priority jobs in front of us is formalising the establishment and conduct of our investment operations, including development of investment policies. The Board has agreed to establish an Investment Advisory Committee (IAC) in the first instance, to drive ahead progress in this area. Formalisation of the IAC is currently being addressed by the General Manager.

There are a number of significant matters that will be complete or near completion by the time this pānui arrives with you. Firstly, the voting on the Te Ohu Kaimoana Review will be completed on 4 June. We will report on the outcomes of that review process in the next pānui. The other significant piece of work soon to reach fruition is the New Space Aquaculture Settlement – Regional Agreement. Negotiations have been completed, and a considerable amount of legal work is currently

being finalised prior to a formal signing ceremony with the Crown scheduled for the end of June 2015.

Again, we will update you all in more detail in our next pānui. Suffice it to say at this stage, that our negotiators have achieved a strong result for us, and all Te Tau Ihu iwi.

In closing I would like to revisit the Te Ātiawa Day celebrations, and reaffirm that the event was an uplifting and joyful occasion for us all, and it was especially uplifting for those of us that live in the rohe to have so many of our whānau join us from afar. It truly was a fantastic time.

# Te Ātiawa o Te Waka-a-Māui Trust formalises its Iwi Environmental Management Plan

This Iwi Environmental Management Plan (IEMP) is the first Iwi Management Plan developed by Te Ātiawa o Te Waka-a-Māui Trust, largely concerning the management aspirations for its Marlborough Sounds' rohe, but also generally expressing the tikanga of Te Ātiawa in Te Tau Ihu.

The timing of this event is auspicious, in that it provides a formal platform for Te Ātiawa, as kaitiaki, in the immediate Post-Settlement World (Settlement for Te Ātiawa occurred on 9 August 2014). This is a necessary and significant step for Te Atiawa as it journeys forward from Settlement.

The outworking of the Settlement process now provides a whole new range of challenges; responsibilities and opportunities for Te Ātiawa o Te Waka-a-Māui Trust. The formal status of the IEMP will go some way to further express the Te Ātiawa position as manawhenua iwi in various parts of Marlborough, but especially in the Queen Charlotte Sound.

With the completion of our settlement last year, the focus has moved to building a sustainable economic group of companies which will ensure benefits to all members going forward. To this end we have Totaranui looking after all of our fishing and aquaculture assets, also those managed on behalf of our Asset Holding Company. The other assets such as forests, commercial properties and investments are being managed by my office under the supervision of the main Board within the Post Settlement Governance Entity [PSGE]. An Investment Advisory Committee has been established to advise the Board on investment opportunities.

I started in October last year and the brief is really simple: Create a financial and economic legacy from the Settlement which will be to the lasting benefit of all our members. To achieve this we have to stay true to our Strategic Plan which not only directs us to achieve Te Pūtea, but also consider our Te Ao Tūroa and deliver on Mātauranga and Whānau for our members. In addition we have to build on Whanaungatanga, Te Kaitiakitanga me te Tāhūhū.

How is all this achieved? Our small but highly dedicated professional office staff create small miracles every day. While **Ian (aka Shappy)** carries our Resource Management flag to very many meetings including all levels of Government, **Noelene** ensures that our member data base is up to date and assists **Trish** with Reception, Accounting and Board requirements. They also assist our Totaranui and Asset Holding Company Directors with a range of support functions.

Our Board members are active across the full range of activities and while their main focus is Corporate Governance, they are active participants in advising and guiding our Operational team. Most of these activities take place at our new offices at Waikawa Marina, although our Board meetings alternate between Tasman and Marlborough.


Tahua-Roa (food for your visitors)

Ashley achieved 2nd in NZ for 15 year girls and was selected to represent NZ in the Oceania BMX Championships in Brisbane Supercross Track in April. In the Aussie Assault race meeting she produced a strong performance placing 3rd in her 15 year girl's age group, then 4th in the Australian Pre-Nationals event. Unfortunately the Oceania BMX Championship event was cancelled due to torrential rain. Ashley had placed 3rd in her moto but on the timing count back she was placed 6th.

Overall Ashley had some great results and exposure to International racing however, Mother Nature had the last say. Excellent performance Ashley.

Unfortunately, Jamie (Ashley's twin brother) was to compete also but broke his collar bone at the Nationals so had to watch from the side-line. Our commiserations go out to Jamie and we wish him a speedy recovery.
